## NOTES FOR THE SECRETARY

- After the Brother is accepted for membership by the Lodge, the Secretary, or an assistant, must update the Grand Lodge data base with the complete Masonic record. The record must include the degree dates, other Lodge(s) of membership and periods of suspension, etc.
- When updating the Grand Lodge database, the Lodge Secretary should audit the Brother's Masonic record for accuracy.
  All data should be based on actual records.
- If the petitioner is from another Grand Jurisdiction, the Grand Secretary must be notified of the Brother's acceptance. The Request for Demit (for affiliation only) must be completed and included in the notification. The Grand Secretary will forward the notification to the affected Grand Lodge.
- If the petitioner is a member of a New Mexico Lodge(s), the Secretary must notify the affected Lodge(s) directly.
- The petition and related documentation are the permanent record of the Lodge.
